But boy, you would never know her condition if you saw her peddling her adult trike down the sidewalks of West Floral Park or Floral Park. Bill wearing his rancher's straw hat, and on cooler days, Mildred with her mittens and fur trimmed bonnet tied under her chin. Bill and Mildred were friends over twenty some years, or so I was told. Bill and his wife Ann became friends with Mildred and her husband Miles. Bill was a painting contractor and Miles an engineer. I believe they met when Bill came to paint Mildred's home. After Mile's passing, Bill and Ann would come by every Wednesday to visit Mildred, share dinners with her and just, well, keep her company. Then after Ann died, Bill began to visit with Mildred after he had finished his work for the day. Over 80 years old, Bill was still actively involved in the painting business focusing on scheduling and bidding. So, he would arrive early afternoon at Mildred's. Bill didn't want Mildred to cook, so they would go out to dinner early evenings. As Mildred's health deteriorated during the past couple of years, Bill would finish his work mid morning so he could care for Mildred. Bill was a generous man of spirit. Have you been wondering*



General Meeting Notes

Santa Ana College

1530 West 17th Street, Santa Ana, California 92706

Erlinda Martinez, President of Santa Ana College and BOT Alfredo Amezcua attended the meeting and shared information regarding the 90th Anniversary for the College as it was started in 1915. Santa Ana College is the 4th largest Community College in California with over 20,000 students. It also resides on the 3rd smallest campus. Erlinda distributed 2006 Calendars for Santa Ana College commemorating 90 years in Orange County. She then went on to explain the immediate goal for the coming years such as; the expansion of buildings, parking facilities and the replacement and/or renovation of old buildings with the assistance of Measure E Funds. President Martinez distributed a handout of the SA College Master Plan and introduced Bob Partridge who explained the Master Plan. After a question and answer period, President Martinez invited all to take advantage of the many activities at the College.



Greg Fernandez and Tony Varella of the City of Santa Ana's Tree Maintenance Division spoke about neighborhood trees. Greg introduced Tony Varella Head of Tree Maintenance for Santa Ana and discussed the situation of trees in Santa Ana. The

City has hired a consulting Arborist for tree health. Sick trees are being replaced with more resistant varieties such as Mexican Sycamore, Chinese Elms, and Arizona Ash. During recent months they have replaced several trees and are watching their health and acclimation to our climate. In the City, we have over 54,000 trees in various states of health. This year, approximately 15,000 trees will be trimmed starting in our area. If you call the City they will take out dead/dying trees and replace them with a 24-inch box tree at your request with similar trees already in the area. You MUST ask for a replacement as they have had incident of residents not wanting a tree and killing it. It is requested that we do not weed-whack around the trees as it will eventually kill them. City employee, Dave Urbin, was identified as the head of the Department responsible for sidewalks and it was encouraged that you contact him for specific problems.



Sergeant Grace of The Santa Ana Police Department reviewed a series of 10-day burglaries occurring in the Floral Park area since Sept. 2005. The teens responsible for these actions were caught in the act of another occurrence. They are Santa Ana residents. He also

described three incidents since Oct 2005 whereby a woman, accompanied by a child, knocks on the door and either says that the child lost a ball in the back yard or that they live in the home behind them and need to look at the fence for various reasons. While they are in the back yard, the house is burgled. Please be on the lookout and notify the Police.

Treasurer Report: Steve Tancredi explained the handout of Profit & Loss and Summary Balance Sheet and answered questions. He announced that the Board is investigating the obtaining of a 501 C3 status with the help of Santa Ana. Email Steve at STancredi@MASTERCRAFTHOMESilc.com

Court of Appeals -

A new 4th District Court of Appeal, Division Three courthouse is under construction at the corner of Santa Ana Boulevard and

Ross. The \$21.8 million facility will compliment the Civic Center complex and ...along with the Superior Court, Federal Court, and the County, State and Federal office buildings, cements Santa Ana's designation as the County Seat of Government for Orange County. The building will be under construction by March 2007 and completed by September 2008. The 4th District Court, Division Three handles appeals from decisions made at Superior Court throughout Orange County. There are eight Justices and over 100 staff members that will occupy the three story building. MainPlace Mall -

Westfield Group, the largest owner of shopping centers in California and the owner of Main Place, has agreed to purchase the site of Main Place

retailers Robinsons-May north and Macy's from the retail giant Federated. As part of the real estate transaction, Westfield plans to remove buildings and replace them with shops, restaurants and theaters that can help the centers compete with newer venues such as The Grove in Los Angeles. The move is part of an industry trend toward creating airy shopping centers that more closely resemble Main Street. Westfield plans to spend millions of dollars upgrading malls such as MainPlace in Santa Ana and one or two of the stores may be replaced with new, reconfigured department stores, but most of the new tenants will be smaller specialty retailers (information from Los Angeles Times).

Dollars & Cents

If you have studied the 2005 Profit & Loss Statement at the general meeting you'll notice a Net Loss from last year's operations - Please don't be alarmed. The 2005 Board expanded the annual Holiday Celebration and if you attended that year end event, I'm sure you'll agree it was worth the expenditure. The 2006 budget will anticipate a Holiday Celebration of similar quality.

Our social events are well known inside and outside our neighborhood and rightly so because our Social Committee works extremely hard to stage an event that is both memorable and fun. Our social events are wonderful opportunities to meet new friends and neighbors. I encourage you to consider getting more involved in all our committees. The Board is studying the possibility of changing our tax status from Charitable Trust to Not For Profit 501-3C. We believe this change would allow the Association to receive more community support for our social events and put less strain on membership revenue. As this process develops I will be updating the Board each month and residents at each General Meeting.

Our association accounting has 'room for improvement' and I'm working with City provided consultants and community professionals to 'put our house in order'. Based on her love for dogs, Mildred's favorite causes were the Seeing Eye Dogs and in her later years, she also contributed to the Santa Ana Police Force's Canine Unit. She and Bill knew most of the neighborhood dogs by name. Bill had a sixth sense, or so I believe. Late last year, he initiated the sale of Mildred's cars and they began cleaning out her old papers, photos and cards in the back room. The entire house was gone through and "made ready" just in case. Bill's tragic death at 85 occurred, through his generous spirit. He had taken Mildred to a doctor's appointment when they were hit by an allegedly drunk driver. Bill survived for a few weeks, Mildred a couple of months. There were boxes and boxes and boxes of jigsaw puzzles that Mildred said she had put together while her dear husband Miles had worked at his workbench, all tied securely with string so not to lose a single piece, they were saved for another day. I wanted to stay longer and hear so much more but next a peek out the back door to the patio where Bill said they shared lunch every day. Then on to the garage where wonderful pictures of the beautiful young Mildred, the military Miles, the businessman Miles, the beautiful brick home she inherited somewhere in the midwest, where she said a niece had to live in the attic on the 3rd floor, the stories were starting to pour out and as suddenly as they were shared they were suddenly over for the day as Mildred had had enough and went into the kitchen closing the door behind her. 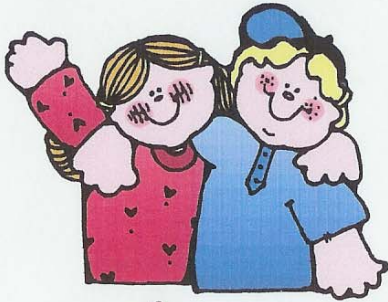

Congratulations to all winners and many thanks to everyone who decorated their homes making our neighborhood a delight to drive through. Bows were placed on all of Santa Clara trees. After years of the same look and several complaints, those bows were retired. Look for something new and exciting for Christmas of 2006.

Our first event of 2006 will be the selection of three nominees for "Most Beautiful Yard Contest". The city has been sponsoring this program for 18 years, created to recognize Santa Ana residents who have improved and maintained their homes. So get your winter and spring planting done early if you intend to win. Most likely our committee will be judging over the weekend of April 1st or 8th.

Saturday April 22 will be our Clean Up Weekend supported by the City of Santa Ana for many years. The committee will designate the locations for the five dumpsters and assign people to monitor each dumpster. Fliers will be distributed listing the locations, times of service and a list of items of what can and cannot be disposed of.

In addition to the programs sponsored by the city, the Committee will do it's share of planting flowers at Santa Clara & Bristol. From time to time we will gather to trim & clean out the beds and the others located at Santa Clara & Towner and Santa Clara & Lowell. The city supports painting of the backs of any traffic signs and post black to keep them uniform and appealing to the eye.
